**Sub: Early settlement of the anomalies raised before the National Anomalies Committee pertaining to anomalies of the MACP Scheme**

A large number of issues pending before the National Anomalies Committee are creating frustration among the Central Government Employees, particularly Railwamen.

During the last meeting, your goodself as well as Jt. Secretary(Estt.) and Jt. Secretary(Pers.) had stated that the remaining issues would be discussed and resolved at an earliest. We had raised issues pertaining to anomalies, particularly in respect of MACPs, pay fixation of promotes at the minimum of the grade at par with direct recruits, treatment of employees selected under LDCE/GDCE at par with direct recruits and their earlier promotions/services rendered should be ignored for the purpose of MACPs as was being done in ACP Scheme, treatment of GP Rs.5400 in PB-II and GP Rs.5400 in PB-III should be treated as same grade pay for the purpose of MACPs, stepping-up of benefits to the seniors from their juniors, benefit of one increment in case of status promotion, e.g. MCM, Loco Running Staff, S.M, P. Way Supervisors, etc., allotment of Grade Pay Rs.4800 to the Supervisors of the apex grade, counting of training period and abolition of Grade Pay Rs.2000 for the purpose of financial upgradation under MACP Scheme, date of effect of MACPS form 1.1.2006 instead of 1.9.2008 etc.

It will be highly appreciated if these issues are considered favourably well before the next meeting.
