EXPRESSION OF INTEREST

Railway Board has decided to assign some Railway works to PSUs on competition basis as per modality approved by Railway Board.

2. Various Directorates of Railway Board viz. Railway Electrification, Signalling, Bridges, Works etc have identified the works which can be assigned to PSUs. Areas in which it is likely to invite PSUs for execution of Projects are **Railway Electrification, Signalling, Telecom, Road Over Bridges, Works and Rolling Stock.**
3. As per the modality, a masterlist of PSUs is to be prepared for awarding the works on competition basis. Once the masterlist of PSUs is compiled, the PSUs figuring in the masterlist shall be asked to submit quotations for the different works.
4. Necessary documents for the quotation – The sanctioned cost and abstract estimate shall form part of the document. 15 days notice will be given to PSUs for submission / opening of bids. No earnest money or security deposit will be taken from PSUs before or after award of works.
5. Participating PSUs will be required to quote a single mark up as percentage of the cost of the project as Consolidated Management Fee. They shall not be permitted to quote any special conditions.
6. The capacity and capability of the PSU will be considered by the Committee to undertake and complete projects w.r.t. the past records and available pending projects in hand. The financial details and experience in specific sectors for last 5 years such as net worth, turn-over, experience in related projects will be considered before allotting works to PSUs.
7. Respective PSUs are requested to give their Expression of Interest for the above works along with details of last five years comprising of financial data, experience in the sector in which they intend to compete, and the track record for the last five years ie. Details of projects awarded with list and details of projects completed in the last five years.
8. This Expression of Interest is general in nature and the PSUs will have the liberty to submit their bids in response to quotations as and when issued.
9. Responses may be submitted within 15 days of issue of this EOI to ED/PSU Railway Board, Room number 152D, Rail Bhawan, New Delhi – 110003, or by email to vinay.s@gov.in along with all documents.
