<b>For Kidney Transplant Patients</b>	<b>For Liver Transplant Patients</b>
Post operatively the patient will be kept in a post transplant ICU for 5 days. Following this he will be kept in single bedded/Isolation Room for another 5 days.	Post operatively the patient will be kept in post transplant ICU for ten days. Following this he will be kept in single bedded/Isolation Room for another 10 days.

This facility shall be provided to all such railway patients irrespective of their pay scales.




