Sub: Revision of Stipend to trainee Senior Section Engineers & Junior Engineers as per Seventh CPC Pay matrix.

We bring to your kind notice the following issue for favorable consideration and early decision:

1. Orders are keenly awaited for revision of stipend as per 7th CPC Pay matrix for directly recruited trainee SSEs (Senior Section Engineers) & JEs (Junior Engineer) as well as those selected through Limited Departmental Competitive Examination (LDCE) who are required to undergo initial / pre-promotional training of one year.
2. As per the revised training module circulated vide Railway Board's orders cited above, all directly recruited SSEs & JEs as well as those selected through LDCE are required to undergo one year's training before absorption as JE/SSE.
3. Stipends of trainee Junior Engineers and trainee Senior Section Engineers were revised after Sixth Pay Commission, to Grade Pay of Rs.4200 & Rs.4600 respectively in PB-2, 9300-34800.
4. Consequent upon implementation of 7th CPC recommendations vide Railway Service (Revised Pay) Rule, 2016, RBE No 90/2016, dated 28.07.2016, SSE & JE are placed in the pay matrix of level 7 and level 6 respectively, w.e.f 1.1.2016.
5. But stipend for trainee SSEs and JEs have not yet been revised as per 7th CPC pay matrix and they are still being paid the Stipend as per 6th CPC Grade Pay till now.
6. **It is, therefore, requested to please revise the rates of stipend for the trainee SSEs to Rs.44,900 in pay level - 7 and JEs to Rs.35,400 in pay level - 6 w.e.f. 1-1-2016.**
