Sub: Proposal for Court Case for higher Grade Pay of CMA, CMS, DMS & CDMS

- 1. Proposal to file a Court Case for higher Grade Pay of CMA, CMS, DMS & CDMS, is under consideration of IRTSA, as persistently demanded by C&M Staff due to non-acceptance of the demand by the Railway Board.
- 2. a) CEC IRTSA is Meeting at Chandigarh on 19th July, 2013. Revised Notice & Agenda thereof, including this point, is attached herewith to consider & decide about the issue for further action.
- b) Court Case filed at Kolkata (by some CMAs including Er. Dinesh etc.) for higher GP for CMA should continue independently at Kolkata. But since it deals only with the issue of CMA I. there is need to file a separate Case for higher GP of CMA, CMS, DMS & CDMS.
- 3. a) Representatives of CMA, CMS, DMS & CDMS are requested to attend the CEC Meeting as Special Invitees to give their views.
- b) Some of the Representatives of CMA, CMS, DMS & CDMS, may be required to stay back for a day to prepare the Brief for the Advocate for filing the Case. Er. KV Ramesh, JGS will coordinate.
- 4. a) Court case for Grade pay of Rs.4600 for JE and Rs.4800 for SSE has already been filed. Highlights of the same are again attached for ready reference.
- b) Court Case for Group B for SSE, CMS & CDMS is also proposed to be filed early as already decided by the CEC IRTSA.
- 5. CMA, CMS, DMS & CDMS are requested to offer their comments on the following points at the earliest to enable the CEC to take decision in this regard:
- i) Send a list of Legal points and arguments for which (in your opinion) should be included in the Petition for Court Case for higher Grade Pay of CMA, CMS, DMS & CDMS;
- ii) Convey willingness of majority of CMA, CMS, DMS & CDMS to contribute at least Rs.1000 per head as the First Instalment for filing this Court Case in CAT within 1 months of the CEC Meeting and further as required,
