Payment of second installment of arrears (60%) on account of implementation of Sixth Central Pay Commission's recommendations.

Please refer sub-para (v) of para 3 of Board's letter no. PC-VI/2008/I/RSRP/1 dated 11-09-2008 (RBE No. 108/2008) vide which orders for release of first installment of 40% of the aggregate arrears on account of implementation of 6th CPC recommendations were issued and it was clarified that orders in regard to the payment of the second installment of arrears would be issued separately. The first installment of arrears (40%) has already been paid in 2008-09. It has now been decided that second installment (remaining 60%) of arrears may now be paid to the Railway employees concerned.

Further, in the case of post 01-01-2004 entrants into the Railway services, the second installment of arrears may be released only after individual application forms for registration to the New Pension Scheme have been obtained by the DDO/PAO from the concerned Railway employees.

Railway employees will be permitted to deposit their arrears in their SRPF Account.

Though not mandated, Railway employees are encouraged to deposit their arrears in their SRPF accounts.
