  - iii) a) After how many years of regular appointment are the P-Way Supervisors (PWS) / Senior P-way Supervisors / Track Supervisors & Senior P-Way Supervisors eligible for 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> financial up-grading under ACP / MACPS; and to which scales / Grade Pay in each case?
  - b) Copies of Rules/Orders/Notifications for iii a) above may please be supplied.
  - iv) Copy of the decision taken on Item No. 4 /2011 b) of JCM PNM Reg: Implementation of MACPS in the category of Sr. Supervisors/P.Way in PB-2 with GP `4200.
