# CGB MEETING & 45<sup>TH</sup> ANNUAL CONFERENCE OF IRTSA AT GORAKHPUR RAIL ENGINEERS FROM ALL OVER INDIA URGE UPON THE GOVERNMENT TO REDRESS THEIR DEMANDS

Large number of CGB Members of IRTSA and other Engineers from all over Indian Railways attended the CGB and 45<sup>th</sup> Annual Conference of IRTSA held at Senior Institute, Gorakhpur on 10th & 11th December. Er. N. K. Sinha Zonal Secretary NER – IRTSA & Convener of the 45<sup>th</sup> CGB and Annual conference welcomed all the delegates.

Er. M. Shanmugam presided over the meeting. He highlighted the continuous struggle and major achievements of the Association and called upon the Engineers all over the Railways to strengthen IRTSA to face the challenges ahead and to intensify the struggle for achieving the pending demands.

Er. Harchandan Singh, General Secretary IRTSA submitted the report on activities of IRTSA and the actions taken during the course of the year for the realization of demands. He also highlighted the major problems facing the Rail Engineers and position of each of the major demands and on the organisational front. He indicated the challenges ahead and the need for action regarding the same. He stressed upon the urgent need for acceptance of various pending demands of the Rail Engineers. He also proposed for immediate setting up of Seventh Pay Commission for Revision of wages wef 1.1.2011 and called upon the younger generation to take a lead in the struggle to meet the challenges ahead.

Er. O. N. Purohit, submitted the balance sheet for the Central Account of IRTSA for the year 2009. Er.K.V.Ramesh presented the Balance sheet for *"Voice of Rail Engineers"*. GS report and Balance Sheets of Accounts of IRTSA & VRE were passed by the Central General Body unanimously.

Zonal Secretaries / Zonal Presidents submitted their reports regarding the activities carried out at their respective Zones, Er. Darshan Lal, Zonal President/RCF, Er. K.V.Ramesh, Zonal Secretary/ICF, Er. Rehman, Zonal Secretary/NR, Er. Krishna Rao, Zonal President/SCR, Er. Goutam Maji, Zonal Secretary/CLW, Er. R. B.Singh, Zonal Secretary/WR, Er. Abdul Salam, Zonal Secretary/SR, Er. Goutam Mukerjee, Zonal Secretary/ER, Er. N.K.Sinha, Zonal Secretary/NER, Er Kaushal Kumar/Zonal Secy/RWF. Some other delegates including Er K.K. Srivastva, Er.Yogendra Kumar, Er.Ojha, Er.Hemant Tripati, Er.Garge also spoke on the occasion.

After detailed deliberations, CGB unanimously resolved to amend Clause 7 of the Constitution of IRTSA for smooth & effective working of the Association at all levels. Annual membership was raised to Rs.150 and life Membership to 1500.

Resolutions of Demands were moved by the General Secretary and seconded by the Zonal Secretaries & CEC Members. After discussions, the Resolutions were unanimously adopted by the CGB. President and the General Secretary IRTSA were authorised to take necessary steps for effective pursuance of the same for early acceptance thereof.

The Conference resolved to hold Dharnas and Demonstrations at Sub-unit, Divisional & Zonal level during the month of February 2011 and Rally-cum-Dharna & Mass Demonstration at Delhi during the month of March 2011.

The CGB resolved to undertake direct action in case the main demands of IRTSA were not accepted in the near future and authorized the CEC, Central President & the General Secretary IRTSA to decide detailed programme of the said line of action and to issue any further directives thereof – for early realisation of the genuine demands of the Category.

Election of CEC was unanimously conducted in which Er. M. Shanmugam, Er. Harchandan Singh and Er. O. N. Purohit were elected as Central President, General Secretary and Treasurer respectively. Er.R.B.Singh, Zonal President/NER thanked all the delegates for making the conference a grand success.

#### **EDITORIAL**

## Time to setup Seventh Pay Commission

IRTSA has always been demanding wage revision every 5 years or rather a continuous process of wage revision through a Permanent Pay Body and the demand was rightly conceded by Fifth Pay Commission – though not accepted by the Government.

Date of implementation of 6th CPC would complete 5 year on 1-1-2011. The Government has already conceded to effect wage revision in PSUs after every 5 years. The disparities with PSUs & Corporate Sector have increased further since Sixth Pay Commission submitted its Report. Disparity will now further increase. The PSUs got a big wage hike w.e.f. 2007 thus increasing the gap further with Central Government employees. Next wage review in PSUs is due in 2012 and the wage disparity can be just visualized especially due to fast improvement in economy.

Same criteria of 5 years as adopted in PSUs, should be adopted for revision of wages and pension of Central Government Employees and Pensioners.

DA component in the wages would exceed 50% w.e.f. January, 2011. But merger of DA will not be done (as in the past) due to retrograde recommendations of the Sixth Pay Commission not to merge the DA on reaching 50% but to give only a nominal increase of 25% in some Allowances – other than DA & HRA.

Anomalies in Sixth CPC Report are not expected to be removed - except by a Pay Commission - since the Government is apparently not ready to agree on any of the major issues of concern.

The other view point on demand for Seventh CPC is that since decision on some of the issues arising after Sixth Pay Commission and its anomalies are pending for a final decision and as such it is not appropriate to demand Seventh Pay Commission at this stage. But keeping in view the fact that the Government may take its own time in accepting the demand for Seventh Pay Commission. In the meanwhile the pending issues could be sorted out in the Anomalies Committees or other Forums (like JCM or DC). In any case, the outstanding issues can be referred to the next Pay Commission. As such, the demand for Seventh Pay Commission needs to be pursued effectively – especially keeping in view the heavy inflation and other aspects mentioned above.

Fourth CPC recommended Permanent Machinery to undertake periodical review of the pay, allowances and conditions of service of Central Govt. employees.

Fifth CPC in Chapter 171 had recommended that the "Government may set up a Constitutional body, which should be responsible for maintaining and updating the basic data on pay and allowances of Government employees and to review the pay scales and rates of allowances and other related matters on a continuing basis."

Fifth CPC further proposed that the mandate for such a Pay Body should be to suggest revision of pay scales every year by merger of dearness allowance or with reference to the cost of living index.

The only argument that Govt. can possibly have against the suggestion is that the Govt. will be required to spend more on pay and allowances than it does now, because of the lag between the need for pay revision and the actual revision itself. This is a false argument and fails to take into account the simmering discontent that such a palpably unjust mechanism engenders among its employees.

Fifth Pay Commission recommended that "It would be in the fitness of things if the Permanent Pay Body is given a constitutional status and authority, as is the case with the Finance Commission."

Fifth CPC also mentioned in Para 171.13 in its report that: "In the Chapter on Dearness Allowance we have suggested that each time the CPI increases by 50% over the basic index used by the last Pay Commission it should be converted into Dearness Pay. Such DP should be counted for all purposes, including retirement benefits."

It is regrettable that the Sixth Pay Commission in Para 4.1.18 of its report, had recommended that the DA should not be merged on reaching 50% (and an increase of 25% in some Allowances be given – other than DA & HRA). The Merger of DA on crossing 50% was proposed to be discontinued on the ground that the Increments had been recommended to be on percentage basis (instead of fixed ones in each Scale earlier). It was further contended by the Base point for calculating the Consumer Price Index should also be raised if the DA was to be merged.

Both these contentions of Sixth Pay Commission were not only inconsistent with the recommendations of the previous Pay Commissions; these were also against the established laws of economics on which the very concept of grant of DA and merger thereof after reaching a reasonable level were based – to avoid wage erosion and its distortion.

The demands for Merger of DA after reaching 25% and revision of DA after every 3 months instead of 6 months were summarily rejected by the Sixth CPC. But the worst part of it was that while the Sixth Pay Commission found merit in the recommendations of the Fifth Pay Commission that the "DA should be paid net of Taxes", Sixth CPC failed to make any further comment or recommendation thereon.

Central General Body IRTSA in its recent meeting at Gorakhpur, had demanded immediate setting up of the Seventh Pay Commission for revision of wages from 1<sup>st</sup> January, 2011. IRTSA may be the first one to raise this demand but there is strong justification for the same and we hope that this will soon find many other Trade Unions to take up the issue in right earnest. As it happens always - whenever a new idea is floated it takes time for the people to accept it. But the efforts must go on sincerely and earnestly.

### CENTRAL PRESIDENT - IRTSA VISITS RAILWAY BOARD - FINANCE MINISTRY NOT AGREEING TO UPGRADE THE GRADE PAY

Er. M.Shanmugam, CP/IRTSA visited Railway Board & Federations on 23rd & 24th November along with Er. K.V.Ramesh, Zonal Secretary/ICF and other office bearers. He met GS/NFIR & GS/AIRF and held intensive discussion with them on the burning issues of Technical Supervisors. Both the federation General Secretaries expressed their anguish on Government/Railways indecision on many anomalies arisen after the implementation of Sixth Central Pay Commission recommendations.

The delegation also visited Railway Board and met the officials including Additional Member/Staff, Advisor/Staff, Director/Pay Commission etc. The demand of 2A pass to all JEs (for all in the Grade Pay of Rs.4200) is expected to become reality shortly. Railway Board is likely to take up the issue of 15% up-gradation of SSEs. It is learnt that Finance Ministry is not agreeing on the major heart burning issue of Grade Pay up-gradation.

## DEMONSTRATION BY OPEN LINE ENGINEERS

The BBQ Sub unit of IRTSA has conducted a Lunch Hour Demonstration on 10.11.2010 between 12.00 hrs and 13.00 hrs in front of Sr.CDO / BBQ office demanding immediate action from the administration to address the following serious issues at BBQ Coaching depot.

- Lack of proper infrastructure for Train maintenance.
- Deteriorating yard condition and dilapidated condition of Pit lines.
- > Sewage stagnation in Pit lines.
- Acute shortage of spares.
- Garbage accumulation in Yard and Pit lines due to non availability of proper arrangements to remove the garbage.
- Continuous erosion of trained and experienced manpower due to transfer.
- Lack of proper illumination during Night shifts.
- Lack of proper action to control mosquito, dog and snakes menace.

The demonstration was attended by supervisors and staff of BBQ depot and addressed by Mr.V.P.Abdul Salam Secy/ SR and Mr.M.T.Sujith Kumar WP / SR among others.

## RESOLUTIONS OF DEMANDS ADOPTED BY C.G.B. MEETING & ALL INDIA ANNUAL CONFERENCE OF IRTSA HELD AT GORAKHPUR ON 10<sup>th</sup> & 11<sup>th</sup> Dec, 2010

The 45<sup>th</sup> All India Conference of Indian Railways Technical Supervisors Association (IRTSA) was constrained to note the apathetic attitude of the Railway Administration towards the just demands of the Rail Engineers / Technical Supervisors, due to which these 'Frontline Managers' continue to suffer great humiliation and frustration on account of denial of proper status and emoluments as well as lack of adequate promotional avenues on the Railways.

The conference regretted that Rail Engineers / Technical Supervisors were the worst sufferers at the hands of both Fifth and Sixth Pay Commissions especially since the Engineers / Technical Supervisors were treated worst than the Accounts Clerks, Teaching & Nursing Staff – who had always been in lower scales than the former.

Even the existing relativity of Pay structure of Engineers / Technical Supervisors - after Third & Fourth Pay Commissions - had been disturbed by the Fifth and Sixth Pay Commissions in respect of the Rail Engineers / Technical Supervisors. There were many other Anomalies in the Report of Sixth Pay Commission. But none of the Anomalies have so far been removed although over 2 years have passed since the acceptance of the Report of Sixth Pay Commission.

CMA I (with recruitment qualification of BE & MSc) were treated even more adversely by being singled out to be left in the Grade Pay of Rs.4200 – in spite of clear-cut recommendations of Sixth CPC to grant Grade Pay of Rs.4600 to posts with Engineering Graduate as recruitment qualification.

The conference regretted that the orders had yet not been issued by the Railway Board on some of the issues like the Revised Entitlement of Passes and Revised coverage under the Group Insurance Scheme etc. No decision had yet been taken on the revised distribution of Posts and the duties & responsibilities after the merger of scales. Even the orders on Revised Designations were "Provisional".

No major decision had yet been taken in National Anomalies Committee (NAC). Even the recommendations of Departmental Anomalies Committee (DAC) – (for higher Grade Pay of Rs.4600 to JEs & Grade Pay of Rs.4800 to SSEs & CMS etc.) have yet to be approved by the Ministry of Finance. Cadre Restructuring Committee (CRC) has yet to start working in right earnest.

Duties, responsibilities and job requirements of Front Line Engineers / Technical Supervisors have increased manifold over the years due to modernization and sophistication of the Rolling Stock and Locomotives, Signal & Telecommunication, Works, P-way and Bridges etc. on the Railways. But it was regrettable that neither the last two Pay Commissions nor the Railway Board have given the due credit for the same while determining their Pay Scales, Grade Pay or avenues of Promotion – in spite of strong recommendations for better status, emoluments and better Avenues of Promotion for them, by the Railway Accident Inquiry Committees and Railway Reforms Committee etc.

All this has greatly demoralized the Rail Engineers. This is bound to seriously and adversely affect their efficiency and that of the system as a whole.

The Conference, therefore, once again urged upon the Railway Board and the Government to favourably consider and redress the following just demands in the interest of natural justice and for greater safety and efficiency and for better job satisfaction of Supervising Engineers on the Railways:

#### Main Demands

**1. Recognition of IRTSA** to provide suitable Forum to discuss and resolve the problems of the middle management category of Engineers / Technical Supervisors on the Railways as per recommendations of Railway Accident Inquiry Committee (RAIC) – 1968 & 1978 & Railway Reforms Committee (RRC)

**2.** Three Times Pay Rise in PB-1 to PB-3 – wef 1-1-2006 (*instead of 2.26 times*) (*over the Fifth CPC Pay Scales*) at par with 3 times rise given in PB-4 & above.

**3.** Merger of DA (Dearness Allowance) with Pay for all purposes w.e.f. 1-1-2011 – when DA crosses 50% - as in the past – (setting aside the unjust recommendations of Sixth CPC in this regard).

**4. Early Setting up of Seventh Pay Commission:** Early setting up of Seventh Pay Commission for Revision of wage structure of Central Government employees with effect from 1.1.2011 – since 5 years have passed since date of implementation of Sixth Pay commission; Govt. has already conceded to effect wage revision in PSUs after every 5 years – same criteria should be applied in case of Central Government employees; Disparity with PSUs & Corporate Sector have increased further since Sixth CPC; DA would exceed 50% w.e.f. January, 2011, but merger of DA is not proposed to be done at this stage due to retrograde recommendations of the Sixth Pay Commission to the contrary.

5. Separate Pay Commission or Wage Board for Railways – in view of peculiar nature of working conditions on Railways.

6. Up-grading of posts of JEs, DMS, CMA-II to Grade Pay of Rs. 4800 – as per their Duties & responsibilities and to maintain "Horizontal Parity & Vertical Relativity" with Accounts Staff etc.

7. Up-grading of posts of Senior Section Engineers, CDMS, CMS & to PB-3 with Grade Pay of Rs 5400 – as per their Duties & responsibilities and to maintain "Horizontal Parity & Vertical Relativity" with Accounts Staff. 8. Up-grading of posts of CMA-I in pre-revised scale of Rs.7450-11500 since Direct Recruitment qualifications of CMA-I are BE / B.Tech. (Chemical / Metallurgical) or MSc (Chemistry); and the Sixth CPC had recommended to upgrade to Pre-revised grade of Rs.7450-11500 – the posts

with Engineering Degree as Recruitment qualifications 9. Time Bound promotion of JEs, DMS, CMA directly as Assistant Engineer (AE) Group 'B' Gazetted - as in all other Government Departments like CPWD and MES,

where the JEs are promoted directly to Group 'B' (Gazetted). **10. Re-designation** of Senior Section Engineers, CDMS,

CMS & CMA-I as Assistant Engineers and their reclassification in Group B Gazetted.

**11. Combined "Cadre Restructuring" of posts in Group 'A', 'B' & 'C'** - to provide adequate avenues of promotion & to fully meet with job requirements.

**12.** Removal of disparity in Cadre Restructuring of Engineers / Technical Supervisors (JEs, & SSEs) vis-àvis other Inspectorial Staff (*like Traffic Controllers & Commercial Inspectors.* (Continued on page-5) (Resolution of demands continued from page-4)

13. Cadre Restructuring of Junior Engineers (JE) & Senior Section Engineer (SSE) in the ratio 40:60%

14. Upgrading of adequate %age of posts from Group 'C' to Group 'B' (Gaz.)

15. Grant of Special Pay to all Technocrats Engineers / Technical Supervisors - like Scientists.

16. Minimum Annual Increment of 5 % PA (instead of 3%).

17. Higher Proficiency Increment in PB-2 & PB-3 at par with PB-4.

**18. Withdrawal of system of uniform date of Increment** (in July every year) and

Either i) Reverting back to the earlier system

**OR** ii) Adopting 2 dates for Annual increments – in January (for those whose increment fell due in January to June) and in July (for those whose increment fell due in July to December).

**19.** Revision of rates of Incentive Bonus & PCO Allowance wef **1.1.2006** - in Railway Workshops & Production Units as per Revised Pay Bands & Grade Pay in keeping with ILO norms – (which require the rates to be based on average of the wages) – or at least 2.26 of the existing rates.

20. Grant of Incentive Bonus to SSE (Senior Section Engineers) at Hourly Rates of Bonus like the JE (Junior Engineers) (as recommended by RITES for Group Incentive Units in Production Units) or raising of the existing rate of Incentive to SSE to at least 30% of Pay (instead of 15%) – (to compensate for loss of takehome- Pay on promotion from JE to SSE.

**21.** Incentive Bonus to S.S.E. in Workshops & Production Units without any deduction for Leave or Holidays or for training or out station duty – as the same is linked with Basic Pay and does not fully compensate for the loss of Incentive Bonus in terms of Take-Home-Pay on promotion from JE to SSE.

22. Incentive rates / PCO Allowance should automatically increase by 25% whenever the dearness allowance payable on the revised pay structure goes up by 50%.

23. Pay element of Incentive to the tune of 30% should be counted for in-service benefits and 55% for Retirement benefits to JEs & SSEs like the Running Staff.

24. Extension to left out areas & Cadres under Incentive Scheme in the Allied Shops & Sections of Workshops & Production Units,

**25.** PCO Allowance to Drawing / Design, Chemical & Metallurgical Lab Staff, Store Depots & IT/EDP Centres in Workshops & Production Units, considering their contribution to improved productivity and quality control (and as already adopted for C & M Staff in DMW Patiala).

**26. PCO Allowance** to JEs, SSEs & other Technical Staff of PCO Cadre in ICF and Southern Railway Workshops - at par with Ex-Cadre Staff Working in PCO in all shops.

**27. Design Allowance to Drawing, Design Staff** – as recommended by Fifth CPC.

28. Extension of Incentive Scheme to Diesel & Electric Loco Sheds, C&W, P-Way, Works & Bridges and S & T Depots etc., to meet with the additional workload in these areas.

29. Honorarium / Incentive to Engineers & Staff for additional workload – *in C&W, P-Way, Works, Bridges & S&T Depots, Sheds, TRD etc*, especially on account of

fluctuating / seasonal rush of workload due to Special Trains, Military Specials, accidents and other exigencies. **30. 2 AC / First Class Pass to all JEs & others in Grade** 

**Pay of RS.4200** – *irrespective of* Date of appointment and at par with other Depts. & as per  $6^{th}$  CPC recommendations for the class of eligibility as per recommendation of Sixth CPC for AC 2 tier travel facility for posts carrying Grade Pay from Rs.4200 & above

**31.** Inclusion of both dependent Parents (father & mother) in Privilege Pass - as Parents are the responsibility of employee and part of family as per Indian culture.

**32.** Three financial Up-gradations under MACPS after every 8 years of service in a grade - at par with Armed Forces (instead of after 10, 20 & 30 years of Service given to Civilian employees).

**33.** Financial up-gradation under MACPS as per cadre hierarchy.

34. Counting of initial Training period for MACPS.

35. Promotion through LDCE (Intermediate Apprentice JEs) should not be counted for Financial up-gradation under MACPS - but as initial appointment.

**36.** Entry grade of Tracers and Assistant Draftsman should be considered from the Grade Pay of **Rs.4200** for MACPS & promotions to the merged / up-graded scales should be ignored – as per accepted policy under MACPS.

**37. Elimination of the discrimination in the MACPS by placing all the Engineering Graduates** in the revised scale with the Grade Pay Rs.4600 - irrespective of their date of recruitment.

41. Restoration of CCA and payment thereof @ 10% of basic pay.

42. Uniform Training Period & Stipend of Trainee J.Es. of all Departments.

**43.** Cadre Restructuring of JE & SSE of Drawing, Design Office at par with other Technical Supervisors / Engineers, due to their common recruitment qualifications as Diploma in Engineering, common training and vital job content & multi-skilled job requirement.

44. Promotion of serving Engineering Graduate J.Es. / S.S.Es against 50% posts of direct recruitment quota of officers with necessary age relaxation.

45. 20% of Pay as P.C.O. Allowance to P.C.O. Staff including J.Es & SSEs.

**46. 30% Special Heavy Duty Allowance to Track Temping Staff & Engineers.** (As recommended by Sub-Committee of Railway Board as long back as in 1996).

**47. 30% Training Allowance** for Faculty of Zonal Training Schools and Technical Training Centres at par with

National/Central Training Academies and Institutes for Group-A Officers.

**48.** Reduction of Working Hours of all Technical Supervisors and Staff to 42 hours a week - as recommended by I.L.O. and National Commission of Labour.

**50.** *Withdrawal* of non-technical duties from JEs, SSEs -for full concentration and effective utilization of Technical Supervisors in technical jobs only since the following duties divert their attention:

i) Custody of Stores, ii) Boxing, Disbursement & witnessing of wages; and

iii) Witnessing of GA attendance card punching etc.

**51. b) Adequate allocation of Staff Benefit Funds (SBF) for Supervisors Welfare.

#### **Railway Board's Orders**

#### 1. Admissibility of House Rent Allowance in the event of non-acceptance or surrender of Railway residential accommodation.

Ref: Board's letter No.E(P&A)II-2010/HRA-2, Dated 8.12.2010

Attention is invited to Board's letters delegation of power to the General Manager and other Heads of Organisatios directly controlling allotment of quarters to Railway servants for sanction of House Rent Allowance in accordance with the prescribed conditions to the categories of Railway employees specified therin. This delegation of powers was valid upto 31.3.2020.

2. The question of renewing this delegation of powers beyond 31.3.2010 has been engaging the attention of the Board. On the basis of the reports received from the Zonal Railways and Production Units, the matter has been considered and the Board have decided to renew the sanction contained in para 5 of their letter dated 16.5.1988 ibid and as amended / modified from time to time w.e.f 1.4.2010 upto 31.3.2017 whereafter the question of renewing this delegation will be considered by the Board and a fresh sanction, if necessary, issued on the basis of reports received from the General Managers etc, directly controlling allotment of quarters, in regard to the position of availability of railway accommodation under their control.

3. In case at any point of time it transpires that some accommodation is likely to remain vacant/un-occupied due to lack of demand, it should be made compulsory to submit applications for such types where there is surplus accommodation, and consequently, the employees entitled for such types would not eligible to draw House Rent allowance.

4. This delegation is also subject to over-riding condition that these orders are liable to be withdrawn/modified at any time during this period, if it is considered necessary by the Board to do so.

2. Sub: Penalty of withholding of Increments imposed under Vth Central Pay Commission scales and operated as per VIth Central Pay Commission Scales effective from 1.1.2006.

In terms of these instructions, issued in the context of implementation of IIIrd and IVth pay commission scales respectively, it was advised that the Appellate/Revising Authority, may, while considering the appeal/revision application submitted against the penalty of withholding of increments take into account the quantum of financial loss that would be sustained by the Railway servant in the preceding pay scale and the greater monetary loss that would result/has resulted on re-fixation in the new Pay Commission scale and accordingly reduce or modify the penalty imposed.

Board has considered the matter further in the light of implementation of VIth Central Pay commission scales from 1.1.2006 and desire that the Appellate/Revising Authorities while considering the appeal/revision petition against the penalty of withholding of increments imposed under Vth Central Pay Commission scales and continuing on 1.1.2006 or imposed/effected between 1.1.2006 and 4.8.2008 that is, the date on which the Sixth Central Pay

Commission Scales were notified on Railways, may also take into account the greater monetary loss that would be sustained by the appellant/petitioner on account of refixation of his pay under the VIth Central Pay Commission Scales from 1.1.2006 and take a suitable decision regarding the quantum of the penalty.

#### **IMPORTANT COURT JUDGEMENT**

# No varying pay if employees are in same posts: Delhi HC

#### Judgment Delivered On: 07th September, 2010 UOI & ANR. – VS - SANJAY KUMAR & ORS. & W.P.(C) NO.2071/2007

There cannot be discrimination among employees holding the same posts and doing similar nature of work in terms of their pay scale unless one has higher qualifications, Delhi High Court has said. The court dismissed an appeal filed by the Centre against the order of the Central Administrative Tribunal which had held that there cannot be discrimination among persons holding same posts vis-a-vis their pay scale while allowing a batch of petitions filed a group of Prasar Bharati employees.". . . where there is complete parity it would be highly discriminatory to treat employees differently merely on account of the two coming from two different sources," a Division Bench of Justices Pradeep Nandrajog and Moolchand Garg of Delhi High Court said. However, the court clarified that the pay scale can vary if an employee held higher qualification than others in the same cadre."Of course, employees in the same cadre can certainly be placed in different pay scales but that would be if it is shown that one set of employees has higher technical or education qualifications or performs more onerous duties vis-avis the other or the like," the Bench added.Prasar Bharati was constituted in September 1997 under Broadcasting Corporation of India Act.

Alleging disparity in their pay scale, the employees had said they were casual employees with the I&B ministry and were offered a pay scale of Rs 5000-8000 after they were regularised under the Prasar Bharti.However, their other counterparts, who were erstwhile regular employees of the same ministry, were offered the pay scale of Rs 6,500-10,500 under the corporation."Merely because they acquired the status as regular employees under the corporation was no ground to justify they being placed in the low pay scale," the employees had contended before the CAT.The Tribunal had in 2007 rejected the arguments of Centre and directed it to give equal pay scale to the Prasar Bharati employees holding the same posts and doing similar nature of job.The Centre had moved the high court against the CAT order.
