GS IRTSA and Zonal Secy SCR intensively tour IRTSA SCR sub units

From 25th to 27th June K.V.Ramesh General Secretary IRTSA and Er.MMVGK. Raju Zonal Secretary IRTSA SCR toured around various sub units of IRTSA South Central Railway. They held meeting with members of following sub units,

In meetings held at above subunits of IRTSA, GS IRTSA explained continuous and relentless efforts mad by Team IRTSA for upgrading 25,000 SSEs form level-7 to level-8 w.e.f. 01.12.2022, non-functional financial upgradation to level-9 after completing 4 years of service in level-8, modifications made in 70% selection for Group-B services protecting interest of seniors, Promotions earned in merged grades (JE-II & JE-I and SE & SSE) between 01.01.2006 and the date of notification of RS (RP) Rules 2008 ignored for the purpose of financial upgradation under MACPS, etc. GS further briefed about efforts made by IRTSA to bring all Technical Supervisors working in different areas under one umbrella with uniform designation & uniform training period. 1st class pass travel eligibility for all JEs, CMS & DMS, inclusion of training period for all purposes except for MACPS, etc.

GS IRTSA explained memorandum submitted by IRTSA and presentation made before Railway Board committee, formed to study about stagnation among Supervisors and grant of Group-B status to SSEs. He said IRTSA had represented issues of Technical Supervisors / Rail Engineers exhaustively from 3rd CPC to 7th CPC. Likewise, IRTSA is getting ready to represent all issues of the categories to 8th CPC. Pending legal battel at CAT Chennai pleading for level-7 for JEs & level-8 for SSEs, long pending demand of Group-B status, etc need to be persuaded more vigorously said GS IRTSA.

Editorial

Creation of additional JE & SSE posts in four technical departments are inevitable, Railways should expediate its initiation, Creation of post should be part of CRC

Indian Railways achieved a growth of 8 per cent in passenger traffic and 5.2 per cent in freight revenue in financial year-24.

In the last 10 years IR added 31000 Km of new tracks. In the financial year 2023-24 itself, Railways added 5200 KM of tracks to its network across the country. Government is pursuing a vision of adding more than 5000 KM tracks on yearly basis for the next 6-8 years. From adding 4 km per day in 2015, Indian Railway is now adding 15 Km per day.

In the year 2024, Indian Railways achieved, 6,450 km of complete track renewal, 8,550 turnout renewals, and raised speeds to 130 kmph over 2,000 km. Electrified 3,210 RKM extending the electrified BG network to 97% with renewable energy capacity reaching 2,014 MW. A record 136 Vande Bharat trains and the first Namo Bharat Rapid Rail were introduced, alongside 21,513 special train trips during peak seasons.

Indian Railways loaded 1,473 MT of freight in 2024, achieving a 3.86% growth, with EDFC and WDFC facilitating over 72.000 train runs.

Work started on 1,198 stations out of 1,337 stations under Amrit Bharat Station Scheme. 10,000 Locos being equipped with Kavach safety technology, 9000 technicians trained and bids invited for 15,000 RKM.

On Rolling Stock production, target for production of passenger coaches for IR's Coach PUs has been increased from 7127 in 2024-25 to 10105 coaches in 2025-26, 42% increase in coach production. Similarly, target of loco production has been increased from 1625 in 2024-25 to 1700 in 2025-26.

Above highlights on improved performance of Indian Railways and determined large developmental programme requires additional posts at the level of JE & SSE.

CRC is long due from Oct 2023. Since last CRC in 2013, key changes happened in IR are listed below, which are self-speaking for the justification to increase the posts of JEs and SSEs in all four technical departments of Railways.

- 1. Number of rolling stocks in possession has increased 32.5% between the year 2011 and 2021, for the period of ten year since last cadre restructure exercise.
- 2. In the same period total track KM has increased by 11.1% and electrified route km has increased by 128.5%.
- 3. But total staff strength was reduced by 5.7% over and above the existing deficient staff strength.
- 4. As on February 2023, Railways is having vacancy of 3.12 lakh (21.2%) in non-gazetted cadre.
- 5. Introduction of semi high speed trains across Indian Railways and corresponding technological upgradation in P.Way, Bridges, OHE, S&T and their maintenance.
- 6. Increase in quantum of passenger and freight traffic.
- 7. To keep the pace with growth, Railways should have to restructure its staffing pattern particularly at supervisory level of technical departments.
- 8. Supervision and certification of work carried out by nonrailway employees (to make up the shortfall in direct manpower, work outsourced to meet increased passenger & freight traffic, outturn, introduction of new technologies, new assets, etc) require higher number of Technical Supervisors at field level.

Adding approximately 10,000 posts at the level of JE & SSE will ensure balanced cadre structure for Technical Supervisors and avoid top-heavy structure. It will also ensure promotion for qualified technicians and induction of young new recruits.

DoE, Ministry of Finance in its OM dated 31.07.2023 permits Railways for creation of new grades or posts, proposals involving additional expenditure. DoE also emphasized that Cadre Restructure should be visualized as an exercise for complete man power planning.

It is time for Railways to create additional JE & SSE posts in four Technical Departments of Indian Railways.

General Secretary IRTSA addresses open line Engineers of Coaching Depot, BBQ

16th June: K.V.Ramesh General Secretary IRTSA addressed Engineers of coaching depot, Basin Bridge, Southern Railway. Er.Suresh Kumar welcomed the gathering and thanked IRTSA leadership for their untiring efforts for the upliftment of the category. He said pay level-8 and NFU to level-9 for SSEs is a historical achievement of IRTSA and it will eliminate stagnation for present Junior Engineers. Er.Unni said that every JE & SSE should be member of IRTSA. He said relevance of IRTSA is felt more significantly now for both career growth and for peaceful working.



General Secretary IRTSA explained about achievements of 50% upgradation of SSEs to level-8, NFU to level-9 without any restrictions on completion of four years of service in level-9, protecting the interest of senior Technical Supervisors in 70% selection for Group-B, etc. He said CRC is getting delayed inordinately for no reasons. He further said, 8th CPC is expected to be formed in near future and IRTSA has to grab the opportunity to get justified pay level for Technical Supervisors / Rail Engineers, allowances etc. GS IRTSA appealed for annual membership subscription and contribution for struggle fund from all members.

Members participated in the meeting expressed about difficult working conditions in the coaching depot, inability to avail weekly rest because of shortage of JE & SSE, restrictions in availing leave even on medical reasons, etc. Replying to a quire GS IRTSA briefed about UPS and said OPS for all Central Government employees is the demand of all unions and Associations. Members expressed concern on severe shortage of staff in the depot.

Item No. 16/SC/63/25 – NPS pensioners to be allowed to CGHS and FMA benefit

On the demand that NPS Pensioners who joined on compassionate ground and retire with less than 10 years' service may be allowed to join CGHS, it was decided that staff side may give a fresh proposal in this regard for consideration of Ministry of Health and Family Welfare.

Item No. 4/SC/63/25 – Revision of Central Government Employees Group Insurance Scheme as proposed by the staff side.

On the demand of Central Government Employees Group Insurance Scheme, it was decided that a copy of the revised proposal of Department of Expenditure may be provided to staff side for their comments.

Item No. 3/19/SC – Maximum coverage under the deposit linked insurance scheme (insurance scheme for central government employees) may be increased from Rs.60,000 to Rs 6.00 lakh.

It was informed that DoPPW has referred to DoE the proposal for enhancement of insurance coverage from Rs.60,000 to Rs.3.5 lak. The matter is under examination in DoE. It was decided the staff side will give its comments in the matter.

Item No. 21/21/SC – Grant of risk allowance to Central Government employees including Defence civilian employees and Railway employees w.e.f 01.07.2017 and inclusion of new hazardous activities in the list of grant of risk allowance.

On the demand of grant of Risk & hardship allowance to Defence civilian employees and Railway employees, it was decided that M/o Railways may refer the matter to D/o Expenditure for its reconsideration. Further, Department of defence would expedite the matter relating to identification of additional posts which may fall into Hazardous category.

Item No.2.2 – The issue of recoveries from retirement benefits of retiring Government servants. Staff side urged to issue clear instructions to Ministries / Departments to prevent such recoveries.

On the issue of recoveries for retiring Government servants, staff side urged to issue clear instructions to Ministries / Departments to prevent such recoveries. Director (DoP & PW) informed that instructions in this regard have been issued vide O.M dated 18.10.2024. It was decided that DoP&PW will issue FAQs in the matter.

Memorandum on following issues were submitted to GS NFIR. GS NFIR discussed the issues in detail and said he will pursue the demands.

- 1) Classification of posts of SSE, CDMS, CMS & SE(IT) in level-8 as Group-B and outcome of the Railway Board committee (Railway Board Order No. ERB-I/2024/23/65, dated 20.11.2024) to examine issues relating to Supervisory Categories.
- 2) Counting of training period of Junior Engineers (JEs), Senior Section Engineers (SSEs) and other Technical non-gazetted staff for financial upgradation under MACPS.
- 3) All the available and arising DR vacancies of SSE, CMS and CDMA to be filed through promotion from eligible JEs, until recruitment of Graduate Engineers through RRB.
- 4) Creation of posts of SSE in Level-8 at ICF.
- 5) Providing opportunity for submitting representations against gradings below "very good" recorded in APARs for the year 2020-21, 2021-22 & 2022-23 for the purpose of MACPS.
- 6) Issue pertaining to upgrading of APAR in Northern Railway Mechanical workshop, Amristar.

GS IRTSA meets GS NFIR along with Pensioners Association of Railways Bittragunta at Gudur,



21st May 2025: K.V.Ramesh General Secretary IRTSA along with members of Pensioners Association of Railways Bittragunta met Dr.M.Ragahvaiah General Secretary NFIR at Gudur. Following issues were highlighted to GS NFIR.

- 1) Establishing new production unit at old steam loco shed area Bittragunta.
- 2) Removal of minimum 20 years of service eligibility for postretirement complimentary pass.
- 3) Restoration of pre covid stopping of express and mail trains at Bittragunta.
- 4) Cadre Restructuring and
- 5) Inclusion of training period for the purpose of MACPS.

Restoration of commutated portion of pension after 12 years.

(Item No. 6/SC/22, Minutes of 63rd meeting of Standing Committee of National Council (JCM) held on 23.04.2025)

It was noted that pensionary benefits had been generally included in the Terms of Reference (ToR) of precious Pay Commissions. It has been decided by the government to constitute 8th Central Pay Commission (8th CPC). However, the staff side insisted that since the matter was already under consideration of DoE for quite some time and broad consensus in the matter had emerged, this matter may be taken up separately instead of being referred to 8th CPC. It was decided to review the demand of staff side by Department of Expenditure.

DoPT issues final orders on Grant of notional increments on 1st July / 1st Jan to the employees who retired on 30th June / 31st Dec respectively for the purpose of calculating their pensionary benefits. Ref: DoPT O.M No. No. 19/116/2024-Pers.Pol. (Pay) (Pt), dated 20.05.2025.

- 1. Supreme Court issued final directions in the matter.
- 2. The judgement dated 11.04.2023 will be given effect to in case of 3rd parties from the date of judgement, enhanced pension will be payable from on and after 01.05.2023.
- 3. For persons who have filed writ petitions and succeeded, an enhanced pension by taking one increment would have to be paid as per judgement.
- 4. Above direction in will not apply, where the judgment has not attained finality.
- 5. In case any retired employee filed an application, before the CAT/High Courts/Supreme Court, the enhanced pension by including one increment will be payable for the period of 3 years prior to the month in which the application was filed.
- 6. In case any excess payment has already been made, including arrears, such amount paid will not be recovered.
- 7. The matter has been examined in consultation with D/o Expenditure and D/o Legal Affairs.
- 8. Grant of the notional increment on shall be reckoned only for the purpose of calculating the pension admissible and not for the purpose of calculation of other pensionary benefits.

A copy of Department of Personnel & Training O.M.No: 34013/1(S)/2016-Estt (B), dated 09.07.2024, on the above subject is enclosed herewith for the information and guidance. Instructions contained in O.M dated 30.11.1966 and 28.10 1980 referred to therein, had been circulated over Railways vide Railway Board's letter No. E(D&A)66GS1-14 dated 05.01.1967 and No. E(D&A)81GS1-11 dated 11.09.1981.

DoPT, F.No. 34013/1(S)/2016-Estt (B), dated 09.07.2024. Subject: Participation of the Government servants in the activities of RSSS – regarding

The undersigned is directed to refer to the OM No.3/10(S)/66-Estt.(B) dated 30.11.1966, OM No. 7/4/70-Est. (B) dated 25.07.1970 and OM No. 15014/3(S)/80- Estt.(B) dated 28.10.1980 on the above subject.

2.The aforesaid instructions have been reviewed and it has been decided to remove the mention of Rashtriya Swayam Sewak Sangh (R.S.S.S) from the impugned OMs dated 30.11.1966, 25.07.1970 and 28.10.1980.

3. This issues with the approval of Competent Authority.

Ministry of Home Affairs OM No.3/10(S)/66-Estt (B), dated 30.11.1966.

Subject: Association of Government servants with the activities of R.S.S.S / Jamaat-e-Islami.

The undersigned is directed to invite the attention of the Ministry of Finance etc, to the provisions of sub-rule (i) of Rule 5 of the Central Civil Services (Conduct) Rules 1964 under which no Government servant shall be a member of or be otherwise associated with any political party or any organisation which takes part in politics nor shall he take part in, subscribe in aid of, or assist in any other manner, any political movement or activity.

As certain doubts have been raised about Government's policy with respect to the membership of and participation in the activities of the Rashtriya Swayam Sewak Sangh and the Jamaat-e-Islami by Government servants, its is clarified that Government have always held the activities of these two organisations to be of such nature that participation in them by Government servants would attract the provisions of subrule (1) of Rule 5 of the Central Civil Services (Conduct) Rules, 1964. Any Government servant, who is a member of or is otherwise associated with their activities is liable to disciplinary action.

The Ministry of Finance etc, are requested to bring the above position to the notice of Government employees working in or under them.

DoPT O.M. No15014/3(S)/80-Estt(B), dated 28.10.1980. Sub: Association of Government servants with the activities of Rashtriya Swayam Sewak Sangh / Jamaat-e-Islami.

The undersigned is directed to invite the attention of the Ministry of Finance etc, to the provisions of sub-rule (i) of Rule 5 of the Central Civil Services (Conduct) Rules 1964 under which "no Government servant shall be a member of or be otherwise associated with any political party or any organisation which takes part in politics nor shall he take part in, subscribe in aid of, or assist in any other manner, any political movement or activity." Attention of the various Ministries is also drawn to this Ministries OM No.3/10(S)/66-

Estt.(B) dated 30th November, 1966, wherein it was clarified that the Government have always held activities of both the Rashtriya Swayam Sewak Sangh and the Jamaate-Islami to be such nature that participation in them by Government servants would attract the provisions of sub-rule (1) of Central Civil Services (Conduct) Rules 1964 and that, any Government Servant, who is a member of is otherwise associated with the aforesaid organisations or with their activities, is liable to disciplinary actions.

- 2. In the context of the current situation in the country, the need to ensure secular outlook on the part of Government servants is also more important. The need to eradicate communal feelings and communal bias cannot be over emphasised.
- 3. No notice should be taken by Government and its officers, local bodies, state aided institutions of petitions or representations on communal basis, and no patronage whatsoever should be extended to any communal organisation.
- 4. Ministry of Finance etc. are, therefore requested to specially bring once again to the notice of all Government employees, working in or under them, the above quoted provisions in para 1 on the subject. It is emphasised that any disregard of these instructions should be considered as a serious act of indiscipline and suitable action initiated against the erring employees.

Re-iteration of the instructions on verifications of claims of candidates belonging to SCs, STs and OBCs for the purpose of appointment to posts/ services - State Level Scrutiny Committee (SLSC) Reports/findings establishing issue of fake/ false Caste certificate and action thereon-reg.

- (i) DOP&T's O.M. Nos. 41034/1/2022-Estt.(Res.-I) dated 29.3.2023 and No. 41034/I
- (ii) / 2022-Estt.(Res.-I) dated 29.03.2023 circulated vide Board's letter No. 2012-E(SCT)I25/2 dated 11.4.2023;
- (iii) DOP&T's O.M. No. 36012/ 6/88/ Estt.(SCT) dated 24.4.1990 circulated vide Board's letter No.90-E(SCT)I/ 31/1 dated 25/31.5.1990 and reiterated vide No.2004-E(SCT)I/99/2 dated 7.7.2005;
- (iv) DOP&T vide OM. No. 36033/9/95-Estt.(SCT) dated 10.5.1995 circulated vide Board's letter No.90-E(SCT)I /71/I dated 27.6.1995;

The nodal Ministry i.e. Ministry of Personal, Public grievances and Pensions (DOP&T) through various O.Ms have issued/ re-iterated instructions/ guidelines regarding streamlining the process of verification of caste certificate of the employees and timely verifications of claims of candidates belonging to SCs, STs and OBCs based on the prima-facie certificate produced by the them for the purpose of appointment to posts/ services. The same have also been re-iterated by Board's office from time to time and latest vide letter No. 2012-E(SCT)I25/ 2 dated 11.4.2023 circulating therewith a copy of DOP&T's O.M. Nos. 41034/ I(ii) / 2022-Estt.(Res.-I) dated 29.03.2023 and No. 41034/ I(ii) / 2022-Estt.(Res.-I) dated 29.03.2023 each.

2. Hon'ble Supreme Court, vide its judgment dated 02.09.1994, in the matter of 'Kumari Madhuri Patil V/ s Addi. Commissioner (1995 AIR 94, 1994 SCC (6) 241) has held that the admission wrongly gained or appointment wrongly

obtained on the basis of false social status certificate necessarily has the effect of depriving the genuine Scheduled Castes or Scheduled Tribes or OBC candidates, as enjoined in the Constitution, of the benefits conferred on them by the Constitution. In pursuance of the above order of the Apex Court, DOP&T vide above referred O.Ms issued detailed guidelines for timely verifications of Caste certificate. 3. As per DOP&T's above OMs dated-29.03.2023, the process for verification of the caste certificate of the employee may be initiated immediately and a communication issued to the concerned State/ UT Authorities within a week of joining of government service by the employee. The State/ UT Authorities have also been requested by DOP&T from time to time to verify the caste/community certificate of the candidates/employees and report the same to the appointing authority within one month of request from such appointing authority. If no report is received from the concerned State/ UT Authorities within a period of one month, the matter may be taken up at the highest level and it may be ensured that the process of verification of the Caste/Tribe/ Community certificate of the employee is completed within a period of six months of her / his joining the service.

- 4. Despite the existing guidelines and its reiteration from time to time by DOP&T and consequently by Board's office, it has come to the notice that cases of false/fake caste certificates gets detected on the verge of the retirement of the employees, and even in certain cases after the superannuation of the employee. The same has been viewed very seriously by the Railway Board.
- 5. Instruction already exist which provides that the services of the candidates claiming to be belonging to SCs/ STs would be terminated, if their claims are found to be false on subsequent verification through District Magistrate. DOP&T's O.M. No. 36012/6/88/Estt.(SCT) dated 24.4.1990 (Circulated vide Boards letter No. 90- E(SCT)I/ 31/1dated 25/31.5.1990 and reiterated vide Board's letter No. 2004- E(SCT)I /99/2 dated 7.7.2005) provides that the Appointing Authorities should, in the offer of appointment to the candidates claiming to be belonging to SCs/ STs, include a clause as follows:

'The appointment is provisional and is subject to the Caste/Tribe certificate being verified through the proper channels and if the verification reveals that the claim to belong to Scheduled Casts/ Scheduled Tribe, as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates". 5.1. Further, DOP&T vide OM.No.36033/9/95-Estt.(SCT) dated10.5.1995 (Circulated vide Board's letter No. 90-E(SCT)I / 71/ 1 dated 27.6.1995) provides that in the offer of appointment to the candidates claiming to belonging to OBC, similar provision/ clause (as like for SC/ST) should also be included.

- 5.2. As per DOP&T 0.M. No.360113/ 2005-Estt.(Res.) dated 9.9.2005, if any person gets an appointment on the basis of such false claim(certificate), his/ her services may be terminated as per conditions contained in the offer of appointment.
- 6. Notwithstanding any of the existing guidelines in this subject, recently, a case of fake/false caste certificate based on complaints, established through the findings/proceedings of District level Scrutiny Committee (DLSC), has been referred to Board's office by one of the Railway / Unit wherein it has been seen that the employee

who is at the verge of his superannuation with his career progression risen to the level of Group-A officer from his initial recruitment grade(Clerk grade-I) seeking to decide the level of authority competent to terminate his service, as he is presently holding the post of Group A officer.

- 6.1. It has been observed by the Board that in su ch cases, the illegal appointment of an employee on the basis of false/fake caste certificate (ST/ ST/OBC as the case may be) brings him/ her back to the status of his initial appointment in the Railway service and accordingly, it has been decided that necessary action to terminate service of such employee(s) should be taken by the respective Appointing Authority of the level of initial appointment. Therefore, such cases need not to be referred to Board's office.
- 7. It is also desired, that a suitable clause to the effect of para-6. 1 above, may also be henceforth incorporated in the appointment letter to as make it very clear to the SC/ ST/ OBC candidates.
- 8. With the above, the extant guidelines/ instructions as mentioned herein are re- iterated and it is desired that the same may please be brought to the notice of all concerned to its strict compliance.

Railway Board letter No.PC-VII/2023/CRC/3, dated 16.05.2025.

Sub: Extension of tenure of Cadre Restructure Committee – 2023.

The Cadre Restructure Committee was formed on 25.04.2022 with a tenure of one year to deliberate upon the requirements of restructuring of Group 'C' cadres across Indian Railways. The tenure of the committee was further extended by one year till 25.04.2024.

- 2. Now, it has been decided by competent authority to extend the tenure of Cadre Restructuring Committee 2023 for a further period till 31.1.2.2025. (copy enclosed)

Sub: Payment of OTA to Supervisory categories/Grades (performing non-supervisory role) of staff of all concerned Departments over the Railways

The issue of non-payment of Overtime Allowance (OTA) to staff in supervisory categories but performing non-supervisory role/duty over Indian Railways had been under consideration as there were demands from both the Federation i.e. AIRF & NFIR in this regard. East Coast Railway had also sought clarification in respect of payment of OTA to Station Superintendent in Grade Pay 4600 working in continuous roster duty i.e. performing duty in non-supervisory role.

2. The matter was examined in Board's office and clarification was issued to East Coast Railway vide letter No.2023/E(LL)/OTA/3 dated 14.02.2024 & 01.05.2024 that as per extant instructions as contained in Railway Servants (HOER) Rules, 2005, those Railway Servants who are

employed on duty having supervisory character/role are not eligible for Overtime Allowance (OTA), as they are comparatively free to adjust his hours of duty or work during such hours by the virtue of the nature of his work and position. However, the eligible cases for grant of Overtime Allowance (OTA) for all concerned categories of staff posted on supervisory grades but performing non-supervisory role/duty may be examined and considered in consultation with FA&CAO in terms of Board's letter No. E(LL)84/HER/1-27 dated 30.11.1984 (copy enclosed)

3. The above clarification is reiterated for information and necessary action.

Railway Board letter No.E(LL)84/HER/1-27, dated 30.11.1984

Sub: Hours of Employment Regulations Supervisory Staff. Guidelines pending revision of the list of supervisory staff.

A number of references have been received representing that consequent upon the restructuring of cadres and upgradation of posts on percentage basis, the list of Supervisory Staff circulated vide this Ministry's letter No.E(LL)70/HER/16 dated 4.1.1972 may be revised so as to reflect the position now obtaining in the matter.

2. The matter has been examined and it is clarified that the question of revisiong the list of supervisory staff, which is under the consideration of Departmental Council, has been referred to a committee of the Council. Pending revision of the complete list, the following guidelines should be followed by the Railways: -

Those staff who were earlier considered non-supervisory as per 1972 list and were entitled for overtime but have now been placed after cadre restructuring in categories and scales which are supervisory as per the said list, need not be automatically made ineligible for payment of overtime. In each of such cases a detailed examination should first be carried out in regard to the duties actually performed/allotted (supervisory or non-supervisory) in consultation with your FA & CAO. If such examination reveals that after cadre restructuring redistribution of duties has been made and supervisory functions added to such posts, then overtime in these cases will not be admissible. If, however, no change in the duties and responsibilities has been made and no supervisory functions have been attached to these posts, the staff concerned may be allowed overtime.

Subject: Extension of cut-off date for exercising Option of Unified Pension Scheme (UPS) under NPS by three months i.e upto 30 September 2025

Please refer to the Regulation 3 (2) (i) of the Pension Fund Regulatory and Development Authority (Operationalisation of the Unified Pension Scheme under National Pension System) Regulations, 2025 dated 19th March 2025, wherein, it is provided that the exercise of option in respect of an eligible employee to covered under UPS shall be undertaken: - (i) within three months from 1st April 2025, or within such extended timelines if any, allowed by the Central Government, in respect of a person mentioned under clause (i) and clause (iii) of sub-regulation (1) of regulation 3 of the above regulations.

- 2. The Central Government of India has extended the cut-off date for exercising the option for UPS by three months i.e., upto 30th September 2025 in respect of the following
- (i) migration to UPS from NPS by an existing Central Government employee in service as on 1st April 2025, who is covered under NPS.
- (ii) claim by (a)A Central Government employee who was covered under NPS and who has superannuated or voluntarily retired or has retired under Fundamental Rules 56(j) (which is not treated as penalty under Central Civil Services (Classification, Control and Appeal) Rules, 1965), on or before 31st March 2025 or
- (b) the legally wedded spouse in case of a subscriber who has superannuated or retired and has demised prior to exercising the option for UPS.
